### AGREEMENT AND DISCLAIMER

In consideration of my acceptance as a competitor in the **2005 J/24 North American Championship** (the "Regatta") I, as Owner/Charterer of the yacht described herein, hereby acknowledge and agree that:

#### Abide by Rules

1. I will be bound by International Sailing Federations Racing Rules of Sailing (RRS) 2005-2008, the International J/24 Class Rules, the Sailing Instructions and the Notice of Race at all times during the Regatta;

**Acceptance of Responsibility**

2. I will take any and all responsibility for the seaworthiness of my yacht, the safety and proper function of the rigging, the safety equipment, the trailer, and the ability of my crew.

3. I accept all responsibility and liability for damages howsoever caused to myself, to my crew, to my belongings, to third persons or to their belongings, both ashore and at sea as a consequence of my participation in the Regatta. I hereby waive any rights I may have to sue the race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) with respect to personal injury (including death), property damage, or other losses suffered by myself or my crew as a result of our participation in this event and hereby release the race organizers from any liability for such injury (including death), damage, or losses to the fullest extent permitted by law. I also accept full responsibility for the behavior, actions and dress of my crew, any representatives I may have and of my guests. I will also indemnify and hold harmless the race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) from any lawsuits filed by my crew or my guests with respect to personal injury (including death), property damage, or other losses suffered by my crew as a result of our participation in this event.

**Insurance**

4. I will at all times during the Regatta have valid Third Party liability insurance for my yacht in an amount of not less than Three Hundred Thousand (\$300,000) US Dollars and will provide the Regatta Committee with proof of such insurance at the time of check-in for the Regatta.

**Decision to Race**

5. My crew and I recognize that sailing is an activity that has an inherent risk of damage and injury associated with it. We have read RRS 4, Decision to Race and hereby acknowledge and agree that we are participating in this event entirely at our own risk.

**Disclaimer of Liability**

6. The United States J/24 Class Association, the Corinthian Yacht Club, Fleet 28, 43 & 95, District 1, J/24 Fleet 28, Inc., the sponsors and their agents, will have no responsibility or liability for loss of life or injury to myself, my crew or others, or for the loss or damage to any vessel or property, howsoever caused.

**Media Rights and Permission**

7. The United States J/24 Class Association, the Corinthian Yacht Club, Fleet 28, 43 & 95, District 1, J/24 Fleet 28, Inc., the sponsors and their agents shall have the unrestricted right and permission to use the my name and the names of my crew, the text, photograph or video footage of either myself, my crew or my yacht, and to publish or broadcast all such material (including but not limited to Press and TV advertisements or Internet), for either editorial or advertising purposes or to use the same in press information and that my name and biographical material may also be used or reproduced in any way known in connection with the Regatta.
